SCG will develop and implement a solution to the current bureaucratic and repetitive process of pre-qualification that meets the needs of clients and other stakeholders and is beneficial to the construction supply chain.



HEALTH AND SAFETY PERFORMANCE

Continuously improving the management of safety and the impact of its activities on workers' health is essential for any world class industry. A consistent approach to recognised standards across construction will enhance performance, facilitate a more efficient use of resources, and allow the industry to focus on eliminating, reducing and managing risks at all stages of a project.

SCG will identify where common standards would significantly improve health and safety performance and it will take the opportunity to address some long-standing customs to eliminate waste and demonstrate the value of sharing best practice in reducing accidents and ill health.

Fair and transparent payment practices are essential for a successful construction industry with a strong and sustainable supply chain capable of meeting its clients' needs. 
Quite simply, construction is what everything else relies on.
